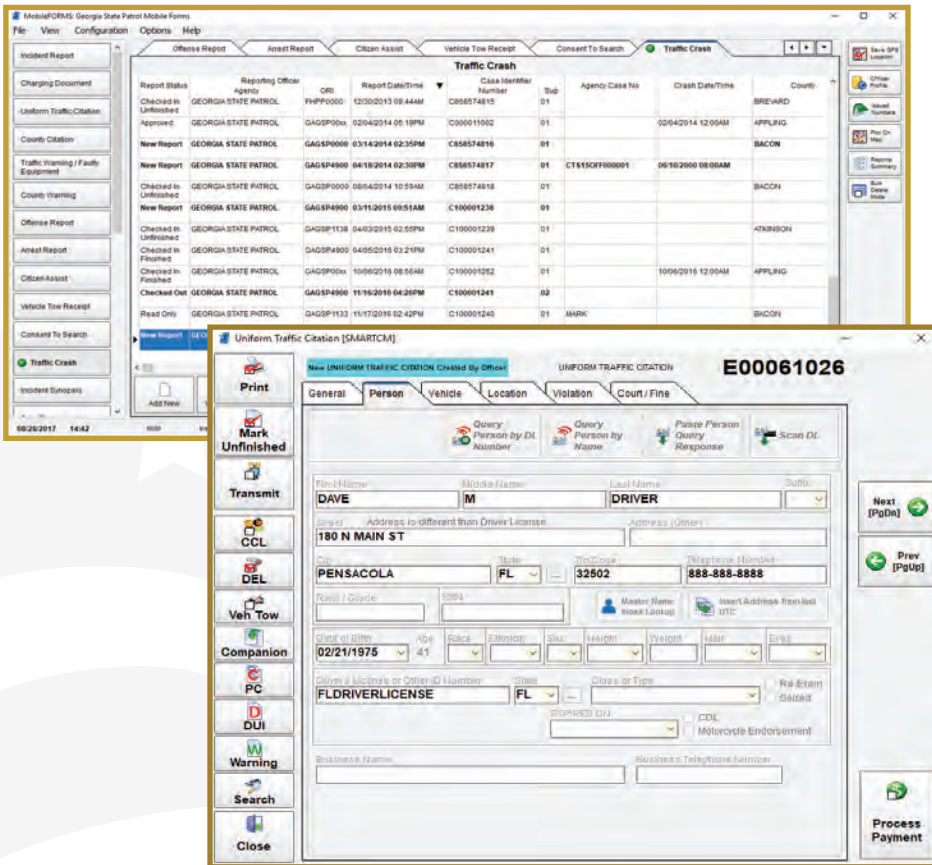

5. Using vehicle in fleeing or attempting to elude officer.
6. Reckless driving.
7. Felony by vehicle.
8. Serious injury by vehicle.
9. Homicide or serious injury by interfering with traffic control device or related apparatus.
10. Controlled substance or marijuana offenses pursuant to 40-5-75.
11. Driving on suspended or revoked license.
12. Driving under the influence of alcohol/drugs.
13. Fraudulent or fictitious use of driver's license.
14. Aggressive Driving.
